Caring For Your Completed Wrap

In today's world of harsh chemical cleaners, acid rain, pollution, smog, and other potential detrimental effects from the environment around you, it is important to care for your vehicle wrap. The following steps detail proper care for your wraps to help keep it looking like new for years to come:

- a) Make sure wrap has been installed correctly using Mactac's *IMAGin®* **GVC929BFD** cast wrap film with *PERMACOLOR® RAYZor™* laminates;
 - LF3648 Gloss, LF3638 matte or CY6398 Sparkle Enhancers.
- b) Before you wash and wax your vehicle wrap do a walk-around to insure no lifted edges or seams.
 - Any you find can be quickly repaired.
 - If it has just been wrapped use alcohol to "freshen the adhesive and reapply. Or, if it
 shows dirt on the adhesive using a small amount of exterior capable, liquid glue
 to do the job.
 - Use sparingly and clean up any excess immediately.
- c) Make sure your wrapped car is clean and free of dirt.
 - Use soap designed to clean automotive surfaces. Do not use household detergents or dish soaps.
 - Wipe dry to eliminate any spotting.
- d) Select a vinyl compatible polish or wax.
 - After testing our graphic products with a number of off-the-shelf waxes and protectants, we have determined that a good silicon based liquid polish will repel the majority of contaminates.
 - Read the label to make sure it is compatible with vinyl graphics.
 - Use as directed, and repeat every 3-4 months.

Just like your car's painted finish, if you want your wrap to last you must take care of it. A little TLC will go a long way.
